**ANTI-BULLYING
COMMITMENT**

1. Introduction

BSCRA is committed to providing a safe, fair and fun environment for everyone in Slot car racing. Bullying of any kind is unacceptable and therefore prohibited by our Association.

BSCRA's Anti-bullying Commitment sets out how we feel about bullying; what we will do to tackle this issue and how we will support people who experience or display bullying behaviour. This commitment aims to contribute to our mission, to inspire and enable more people to participate in our sport in a safe, fair, fun, inclusive and progressive environment. To achieve this, we will seek to promote and provide an environment where everyone can feel:

- Safe
- Valued
- Able to enjoy and achieve their potential
- Able to make a positive contribution

BSCRA will provide a safe and secure environment by continuously working to prevent acts of bullying, harassment, and other forms of aggression and violence.

1.1. Definition of bullying

Bullying is behaviour that hurts someone else. It includes name calling, hitting, pushing, spreading rumours, threatening, or undermining someone.

It can happen anywhere, including on line and is usually repeated over a long period of time with the potential to cause both physical and emotional harm.

A bully is someone who deliberately sets out to hurt another person on more than one occasion.

1.2. Definition of cyber-bullying

Cyber-bullying is the use of technology such as mobile phones, email, chat rooms or social media sites such as Facebook, Snapchat, Instagram or TikTok to harass, threaten, embarrass, intimidate, or target a child/adult. Unlike physical bullying, cyber-bullying can often be difficult to identify and evidence as the bully can remain anonymous when threatening or causing distress to others online.

2. Roles and responsibilities

2.1. The role of the Club

BSCRA has a responsibility to prevent and tackle bullying. The Association will take steps to ensure that all officials and participants act in an inclusive and supportive way to prevent discrimination, harassment, and victimisation within the sport.

BSCRA will educate our officials and clubs to take appropriate steps when they become aware of bullying behaviours.

BSCRA will promote the Motor Sport UK's Race with Respect code of conduct in order to encourage and support all members (officials, competitors and supporters) to speak out about bullying behaviour. The association will follow the Race with Respect procedures to investigate and respond appropriately and proportionately to claims of bullying.

BSCRA will review incidences of bullying at Council meetings to understand if there is anything the Association can learn from and do differently in the future to prevent incidences occurring.

2.2. The role of Association Officials

BSCRA Officials will ensure that bullying behaviour is not tolerated or condoned by working in alignment with the Motor Sport UK's Race with Respect code of conduct, supporting victims of bullying, and reporting incidents they witness or become aware of.

All BSCRA Officials will respond appropriately when they become aware of bullying behaviours, they will notify the Association Safeguarding Officer and signpost to support for victims.

2.3. The role of the Association Safeguarding Officer (CSO)

It is the responsibility of the CSO to promote and implement BSCRA Anti-bullying Commitment. They will support their colleagues to work in accordance with their Clubs commitment, ensuring that incidences of bullying are identified and responded to appropriately. The CSO will ensure that Race with Respect Codes of Conduct is in place, promoted and signed up to by all participants.

When a CSO receives an allegation of bullying, either directly from the person being bullied, or from a witness, they will speak with all relevant parties to understand what has happened and to collect all the relevant information before making a decision in line with Race with Respect procedures.

The CSO will signpost to any support that is required, if the case involves children, the CSO will work with the parents/ carers and the child to discuss any support required.

2.4. The Role of Parents/Carers

Parents/carers have a responsibility to support the clubs anti-bullying commitment by actively encouraging their child to be a positive member of the association.

2.5. The Role of Competitors

All participants of motorsport activities are encouraged to abide by the Motor Sport UK's Race with Respect code of conduct.

If any competitor is the victim of bullying or cyber-bullying, they should speak with the CSO in the first instance for advice and support.

3. Reporting, Sanctions, and Monitoring

3.1. How to Report Bullying

If you are concerned about bullying behaviour within BSCRA, it is important to report it to Will Stemman (the BSCRA Safeguarding Officer).

Where possible provide:

- A clear account of the incident, including the names of people involved
- Details of where and when the incident took place
- Details of any witnesses
- Screenshots of any online bullying (if it is safe to do so)

The CSO will respond as outlined in section 2.3 above.

3.2. Race with Respect

If you do not wish to report incidents of bullying to the association SGO, reports can also be made online via the Motorsport UK website. Reports are reviewed on a regular basis and actions taken forward by the appropriate sporting lead.

Motorsport UK will follow the Race with Respect procedures and implement sanctions as deemed appropriate and proportionate depending on the level of concern.

3.3. Sanctions

Once all evidence has been obtained, the person investigating (whether at a local or national level) will impose a penalty that reflects the bullying behaviour, this may include (this list is not exhaustive):

- Apologising to any effected parties
- Further Education
- Warnings
- Championship Penalties
- Championship round suspension / disqualification
- BSCRA Registration suspension

3.4. Escalation

If the reporting person is dissatisfied with the way BSCRA has dealt with a bullying incident, complaints can be escalated in line with the Complaints policy which can be accessed from Motorsport UK's website.

4. Monitoring, Evaluation and Review

BSCRA's Safeguarding Officer and relevant officials will review this commitment annually and assess its implementation and effectiveness. The commitment will be promoted and implemented throughout the association.
